No. NO. SO(FR)/FD/9-1/2014-15 .-In exercise of the powers conferred by Article 119 of the Constitution of the Islamic Republic of Pakistan, the Governor of the Khyber Pakhtunkhwa is pleased to direct that in the Khyber Pakhtunkhwa Delegation of Powers under the Financial Rules and Powers of Re-appropriation Rules, 2001, the following further amendments shall be made, namely:

**AMENDMENTS**

In the Second Schedule,-

- (a) against serial No. 7,-
- (i) in column No.2, after the word "funds", the words " in the current expenditure budget" shall be added; and
- (ii) under the heading "CONDITIONS", in clause 20, for sub-clause (c), the following shall be substituted, namely:
- “(c) power of re-appropriation of funds, from one scheme to another under the same grant, shall be exercised by the Administrative Secretary, in respect of Provincial Government Departments, a copy of each re-appropriation order shall be sent to the Finance Department:
- Provided that such re-appropriation is essentially required for-
- (vii) early completion of a scheme of importance;
- (viii) more economic or social benefits; and
- (ix) the project which is moved from slow moving to fast track.”; and
- (b) after serial No.7, as so amended the following new entries shall be inserted in the respective columns, namely:

“7A.	Re-appropriation of funds in the development budget.	Administrative Secretary.	Full powers.”.
