Subject: RESTORATION OF PENSION SURRENDERED IN LIEU OF COMMUTATION / GRATUITY TO THE PENSIONERS RETIRED/TO BE RETIRED AFTER 01/12/2001

Dear Sir,

I am directed to refer to the subject noted above and to state that according to para-18(e) of this Department Pay Revision letter No.FD(PRC)/1-1/ 2001 dated 27/10/2001, the benefit of restoration of surrendered portion of pension in lieu of commutation / gratuity was withdrawn.

2. Later on, Finance Department vide its letter No.SOSR-II/FD/4-92/85/Vol-II dated 12/09/2002 decided that benefit of restoration of commuted portion of pension shall continue to be available for those who have opted to remain in the Basic pay Scale 1994.

3. Now the competent authority has been pleased to decide that all civil servants/civil pensioners of provincial government, who retired / would retire on or after 01/12/2001 shall be entitled to the benefit of restoration of commuted portion of pension in lieu of commutation / gratuity in accordance with the applicable rules.

4. The pensioners of provincial Government, who retired between 01/07/2001 to 30/11/2001 and opted for pay scales 2001 on presumptive basis in term of para 19 of this Department Pay Revision letter No.FD(PRC)/1-1/ 2001 dated 27/10/2001 shall also be entitled to the benefit of restoration of commuted portion of pension in lieu of commutation / gratuity in accordance with the applicable rules.


