Subject: INCREASE IN RATE OF HOUSE RENT ALLOWANCE.

Dear Sir,

I am directed to refer to Para 7 of this Department circular letter No.FD(PRC)1-1/87/Vol-VIII dated 22-07-1987 and to state that the competent authority has been pleased to allow the increase in the House Rent Allowance by 50% of the existing amount of Housing Rent Allowance admissible to the Khyber Pakhtunkhwa employees, w.e.f. 01-07-2018, as under:-

Location	Existing	Revised
In declared big cities	45% of the minimum of Basic pay scale 2008	Increase in the amount of House rent allowance @ 50% of the existing amounts being drawn.
Other cities	30% of the minimum of Basic pay Scale 2008	Increase in the amount of House rent allowance @ 50% of the existing amounts being drawn.

2. All other existing terms and conditions regulating the House Rent Allowance will continue to apply.
