Further to amend the North-West Frontier Province
Hydel Development Fund Ordinance, 2001.

Preamble - WHEREAS it is expedient further to amend the North-West Frontier Province Hydel Development Fund Ordinance, 2001 (N.-W.F.P. Ord. No. XXVI of 2001), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and commencement** - (1) This Act may be called the North-West Frontier Province Hydel Development Fund (Amendment) Act, 2006.

(2) It shall come into force at once.

2. **Amendment of section 3 of N.-W.F.P. Ord. No. XXVI of 2001** - In the North-West Frontier Province Hydel Development Fund Ordinance, 2001 (N.-W.F.P. Ord. No. XXVI of 2001), hereinafter referred to as the said Ordinance, in section 3, after sub-section (8), the following new sub-section shall be added, namely:

"(9) An Investment Committee, consisting of the following, shall be constituted to make recommendation to the Board for making investment out of the Fund:

1.	Chief Secretary to Government	Chairman
2.	Secretary to Government, Irrigation and Power Department	Member
3.	Secretary to Government, Finance Department:	Member
4.	Managing Director, SHYDO	Member
5.	Director Finance and Administration SHYDO.	Member."

3. **Amendment of section 4 of N.-W.F.P. Ord. No. XXVI of 2001** - In the said Ordinance, in section 4, in sub-section (3), for the word "three", the word "four" shall be substituted.

4. **Amendment of section 7 of N.-W.F.P. Ord. No. XXVI of 2001** - In the said Ordinance, in section 7,-

- (a) in sub-sections (1) and (3), for the words "Irrigation and Power Department", the words "Finance Department" shall be substituted; and
- (b) in sub-section (2), for words "Chief Secretary", the words "Secretary Finance" shall be substituted.

5. Repeal - The North-West Frontier Province Hydel Development Fund (Amendment) Ordinance, 2006 (N.-W.F.P. Ord. No. II of 2006) is hereby repealed.
