Subject: **GRANT OF MEDICAL ALLOWANCE TO CIVIL PENSIONERS OF THE PROVINCIAL GOVERNMENT.**

Dear Sir,

I am directed to refer to this Department's circular letter No.FD(SOSR-II)/8-39/ 2010 dated 13/07/2010 on the subject noted above and to state that the Competent Authority introduced Medical Allowance w.e.f. 01/07/2010 to all Provincial Government pensioners.

2. In term of para-22 of Finance Department's letter No.FD(PRC)/1-1/2011 dated 14/07/2011 it was decided that:-

- i) Medical Allowance admissible to the existing retired Civil Servants in BPS-1 to BPS-15 and in BPS-16 to BPS-22 @ 25% and @ 20% of their net pension respectively, will continue to be admissible, but the amount will remain frozen at the level of its admissibility as on 30/6/2011, and until further orders.
- ii) All Civil Servants in BPS-1 to BPS-15 and in BPS-16 to BPS-22, who retired on, or will retire after, **01/7/2011**, will be allowed Medical Allowance @ 25% and @ 20% of their net pension respectively, which amount will remain frozen at the same level, until further orders.

3. Now the competent authority has been pleased to sanction w.e.f. 01/07/2015 until further orders 25% increase in the amount of medical allowance being drawn by the pensioners of Provincial Government and to the future retirees on the medical allowance admissible to them at the time of retirement and shall stand frozen at same level.


