## SUBJECT:- ELIMINATION OF CASH PAYMENTS - REDUCTION IN OPEN CHEQUES ISSUED BY AG-KP & PAID IN CASH AT SBP, COUNTER

Dear Sir,

I am directed to refer to this Department letter of even No. dated 19.2.2020 on the subject noted above and to state that it has been observed with great concern that most of the Government Departments/Offices are still practicing issuance of open cheques and even making cash payments to their employees/clients despite clear cut instructions issued by this Department regarding discouragement of cash payments and open cheques. This practice is not only against the spirit of financial control but are also vulnerable to fraudulent attempts and other losses.

I am, therefore, directed to request to immediately stop all kinds of cash payments and open cheques. In case of any critical situation or un-avoidable circumstances, concrete reasons for such payments should be provided to that effect to the concerned Accounts Offices.
