### Simplification of Assan Assignment Account Opening Procedure (Local Currency) 2021

Please refer to our meeting held in Finance Secretariat, KP on dated 02/02/2022 wherein problems faced by KP Government in opening of Assignment Accounts were deliberated.

In the said meeting, NBP proposed Finance Dept. KP to avail bulk account opening facility centrally through NBP Head office. In this regard, we would like to share with you the procedure developed by NBP for opening of Asaan Assignment Account. We would like to inform that several Government Institutions are approaching us for opening of Assan Assignment Account as per Assan Assignment Account Procedure (Local Currency) 2020. Our designated branches are receiving number of requests in bulk on daily basis, so it will be more amicable to adopt the centralized process rather than processing through branches to meet turnaround time.

In order to make the account opening process smooth and efficient we would like to suggest you to have a revised process that is already in place between NBP and Government of Punjab. We have opened around one thousand accounts in timely manner without a single complaint of delay processing.

### Proposed Process for opening and maintenance of Assan Assignment Account (AAA)

- To facilitate Organization/Departments of Government of Pakistan, intending to open Assan Assignment Account (AAA) NBP has the capability to open Assan Assignment Accounts through bulk account opening utility in our core banking system.
- The bulk account opening utility developed for opening of AAA will require transmission of soft data on below format along with scanned copy of sanction advise, from Finance Department, Government of Pakistan to a centralized desk established at NBP Head office.

After receiving soft data from Finance Department (Govt. of Pakistan) NBP Head office will
create project CIF's and open Assan Assignment Account through bulk utility option at
specified NBP Branches mentioned in data file.





- The hard copy of the sanction letters will be dispatched by Finance department to NBP Focal Person-Wing Head, Govt. Account Operations Wing, BOG, 12<sup>th</sup> Floor NBP Head office.
- Initially the accounts will be opened with zero ceiling by default.
- Detail of accounts opened through bulk option will be email to Finance Department (G.O.P) and dealing NBP Branches for completion of further requirements from authorized signatories.
- Finance department will advise the Account Number to relevant departments with the advice to contact NBP branches for completion of following requirements/provision of documents.
- The authorized signatories of AAA will approach the branch and will provide the following:
  - 1. Copy of sanction Advice of Finance Department.
  - 2. Request from user organization (i.e. Ministry/Division/Department duly approved by the PAO's for opening of Assignment Account on Form A.
  - 3. Copy of CNIC's of Signatories.
  - NBP branches will perform Biometric verification and will obtain SS card of authorized signatories. The signatures will be certified/validated from authority letter of concerned department.
  - The authorized signatories will also fill up and sign a simplified KYC form (On Below format).

- 6. Branch will create the CIF's of authorized signatories and tag them with the account already opened through bulk option.
- After completion of all requirements the account will be set operational and branch will provide Account Maintenance certificate to the authorized signatories.

You are requested to kindly consider our above proposal that will not only help in timely processing of Assan Assignment Account (AAA) opening requests but will also have a centralized monitoring and sharing of MIS.
