**No.FD(SOSR-II)4-199/2014-15.** In exercise of the powers conferred by section 26 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 (Khyber Pakhtunkhwa Act No.XVIII of 1973), the Chief Minister of Khyber Pakhtunkhwa is pleased to make the following further amendment in the West Pakistan Civil Services Pension Rules w.e.f. 01/07/2015 namely:-

**AMENDMENT**


In rule 4.10, in sub-rules (2) (A):-

- (a) For clause (iii), the following shall be substituted, namely:
- “iii) failing (i) & (ii), the pension shall be divided equally amongst the surviving widowed daughters for life or till their re-marriage”.**
- (b) After clause (iii), as so amended, the following new clause shall be inserted, namely:-
- “(iii-a) failing (i) to (iii), the pension shall be divided equally amongst the surviving Divorced daughters for life or till their re-marriage.”; and**
- (c) for clause (iv), the following shall be substituted, namely:-
- “(iv) failing (i) to (iii-a) to the eldest widow of a deceased son of the Government servant”.**
