In continuation of this Department's letter of even number dated 27/07/2020 on the subject noted above, Finance Department further agrees to release 15% of the budget allocated under Current Expenditure (Provincial) including merged areas as per break up given below:

## NOTE:

- Repair & Maintenance \*\*:- The funds allocated for civil works, maintenance and repair of Roads, Highways and Buildings and Irrigation Works, will be released on case to case basis on the approval of competent forum and issuance of Administrative Approval.
- 2. Release of Withheld Budget: The withheld budget under Current Expenditure (Provincial) will be released in 2nd quarter of current financial year subject to availability of financial resources. The individual demands for release of balance funds shall be examined at the level of concerned Sections and decided by the competent authority based on justification(s) provided by the Administrative Department concerned."
- 3. Grant in Aid: Grants in Aid will be released subject to the provision of Bank statement by the concerned autonomous entity after unconditional releases in 1st quarter. All Grants in Aid to Bar Councils and Press Clubs shall be released as per approved criteria. Any funds over and above the approved criteria shall be released with the approval of Chief Minister, Khyber Pakhtunkhwa.
