NOTIFICATION:

No. FD (SOSR-IV)/3-21/2025/Prisons Allowance: In pursuance of the decision of the Provincial Cabinet in its special meeting held on 13.06.2025 and in supersession of all previous notifications regarding Prisons Allowance to the employees of Prisons Cadre of Prisons Department; the Government of Khyber Pakhtunkhwa has been pleased to revise and fix Prisons Allowance @ 100% of the Initial Basic Pay 2017 w.e.f. 1st July, 2025.


2. The above allowance will be admissible subject to the following conditions:
- It will be subject to Income Tax.
 - It will not be counted towards pension and commutation/gratuity.
 - It will be admissible to employees on Special Duty (OSD), however, the same will not be admissible to employees who are on Extra Ordinary Leave (EOL) or Suspension or on Earned Leave beyond more than 120 days.
 - The officers of other cadres working against the prisons cadre posts are not entitled to the above allowance.
 - Officers employed on pay package other than National Pay Scale (Contract, market-based salary scale, etc.) are not entitled to this allowance.
