Office:** In pursuance of the decision of the Provincial Cabinet in its special meeting held on 13.06.2025 and in supersession of all previous notifications regarding Judicial Allowance to the employees of the Advocate General Office Khyber Pakhtunkhwa, the Government of Khyber Pakhtunkhwa has been pleased to enhance Judicial Allowance to all the employees of Advocate General Office, who are already in the receipt of the Judicial allowance from 20% to 30% of the Running Basic Pay w.e.f. 1<sup>st</sup> July, 2025.


2. The above allowance will be admissible subject to the following conditions:
- It will be subject to Income Tax.
  - It will not be counted towards pension and commutation/gratuity.
  - It will be admissible to employees on Special Duty (OSD), however, the same will not be admissible to employees who are on Extra Ordinary Leave (EOL) or Suspension or on Earned Leave beyond more than 120 days.
  - Officers employed on pay package other than National Pay Scale (Contract, market-based salary scale, etc.) are not entitled to this allowance.
