NOTIFICATION

NO. SO(SR-IV)/FD/1-1/Risk Allowance/2022: In pursuance of the decision of Provincial Cabinet taken in its meeting held on 13.06.2022, the Government of Khyber Pakhtunkhwa has been pleased to rename the Incentive Allowance as Risk Allowance and enhance the same at the rate of 35% of 2017 initial basic pay to the field staff of Rescue -1122, BPS (03-16) w.e.f. 01.07.2022.


2. The above allowance will be admissible subject to the following conditions:
 - i. It will be subject to Income Tax.
 - ii. Those Officers/Officials who are posted against other posts and are in receipt of Special Allowance other than regular allowances shall only be entitled to one of the allowance, whichever is more beneficial.
 - iii. It will not be admissible to the employees other than regular employees working against the sanctioned posts of Rescue -1122, Khyber Pakhtunkhwa.
 - iv. It shall not be treated as part of emoluments for the purpose of calculations of pension /gratuity and calculation of House Rent etc.
 - v. It will not be admissible in any kind of leave as well as posting against OSD and Leave Reserve Posts.
 - vi. It will not be admissible to the officers/officials posted/deputed outside Rescue -1122, Khyber Pakhtunkhwa.
