**NOTIFICATION**

**No.FD(SOSR-II)8-14/2015.** The Competent Authority has been pleased to approve that the Special Science & Technology Allowance has been discontinued and henceforth all the Ph.D/D.Sc Degree holders will be allowed Ph.D/DSc Allowance @ Rs.10,000/- PM instead of Ph.D Allowance @ Rs.2,250/- or Special Science & Technology Allowance @ Rs.7,500/- per month.

2. It has also been decided that, henceforth, the Ph.D/DSc Allowance shall not be linked with the category of subjects and will be admissible irrespective of place of posting or job assigned to the person concerned. However, it will not be admissible for more than one subject.

3. All the orders regarding Science and Technology Allowance and Ph.D Allowance, issued earlier shall stand modified to the extent indicated above.
