GRANT OF ADHOC RELIEF ALLOWANCE 2019 @ 5% & 10% ON RUNNING BASIC PAY TO THE CIVIL EMPLOYEES AS WELL AS 25% INCREASE IN THE SPECIAL PAY ADMISSIBLE TO PSs & PAS TO MINISTERS, SECRETARIES, SPECIAL SECRETARIES AND ADDL: SECRETARIES OF THE PROVINCIAL GOVERNMENT.

Dear Sir,

The competent authority is pleased to sanction w.e.f 1st July, 2019 and until further orders, an Adhoc Relief Allowance - 2019 to the civil employees of the Provincial Government as well as contract employees employed against civil posts in Basic Pay Scales on standard terms & conditions of contract appointment as detail given below:-

- Adhoc Relief Allowance @10% on running basic pay to all (1) Provincial Government employees from BPS-1 to 16 w.e.f 1st July, 2019;
- Adhoc Relief Allowance @ 5% may be granted to all Provincial (2)Government employees in BPS-17 to 19 on running basic pay w.e.f 1st July, 2019. This increase will not be admissible to those employees who are drawing the Health Professional Allowance, Special Judicial Allowance, Scheduled Post Allowance, Technical Allowance, Prisons Allowance and Prosecution Allowance:
- Special Pay admissible to Private Secretaries / Personal (3) Assistants to Ministers, Secretaries, Special Secretaries and Additional Secretaries sanctioned vide Finance Department's

circular letter No FD/SOSR-1(PRC)1-1/2015 dated 22rd Sep. 2015 may be enhanced by 25% on the existing Special Pay w.e.t 01-07-2019:

- The amount of this Adhoc Relief Allowance 2019:-2
 - will be subject to Income Tax.
 - will be admissible during leave, and entire period of LPR except extra-ordinary leave.
 - will not be treated as part of emoluments for the purpose of calculation of pension/gratuity and recovery of House Rent,
 - iv. will not be admissible to the employees during the tenure of their posting / deputation abroad.
 - v. will be admissible to the employees on their repatriation from posting/deputation abroad at the rate and amount which would have been admissible to them had they not been posted abroad.
- The term "Basic Pay" for the purpose of Adhoc Relief Allowance -2019 will also include the amount of personal pay granted on account of annual increment(s) beyond the maximum of the existing pay scales.
- The above Adhoc Relief Allowance 2019 shall be accommodated / met out within the budgetary allocation for the year 2019-20 by the respective departments / organizations, and no supplementary grants would be given on this account
