
Subject:- **FINANCIAL ASSISTANCE TO THE FAMILY OF A CIVIL SERVANT WHO DIES WHILE IN SERVICE**

Dear sir,

I am directed to refer to this Department's letters of even number dated 16/02/2006, 28/09/2007, 26/02/2008, 21/01/2014 & 30/11/2015 wherein the fundamental rates, relevant rules, procedure to process the cases, sanction and funding for the subject assistance were mentioned.

A question has arisen as to who is the competent / sanctioning authority for the subject financial assistance. It is clarified that:-

- i) Financial assistance to the families of Civil Servants in BPS 1-16 of the devolved Departments who die while in service shall be sanctioned and paid by the District Governments.
- ii) The Deputy Commissioner shall process the cases of financial assistance on priority basis and ensure the payment as early as possible, from the District Account-IV.
- iii) The term "family" as defined under rule 4.7, 4.8 & 4.10 of Khyber Pakhtunkhwa Civil Servant Pension rules and orders (updated up to 15/07/2006) may be adopted for the purpose.
- iv) District Government may arrange payment of financial assistance out of district account-IV after observance of all codal formalities as required under rules and giving proper budgetary cover in their respective district budget.
- v) The cases of remaining civil servants BPS 1-16 of non-devolved Departments (Provincial Government Departments), BPS-17 and above shall be sent to Finance Department for approval / sanction.
- vi) The Budget Officer concerned will process the cases received from the respective Administrative Departments/Deputy Commissioners and issue advice accordingly.
- vii) The subject Financial Assistance shall not be admissible to the family/legal heirs of all such employees, to whom the compensation under Notification of even number dated 16/03/2015 is extended/allowed.
